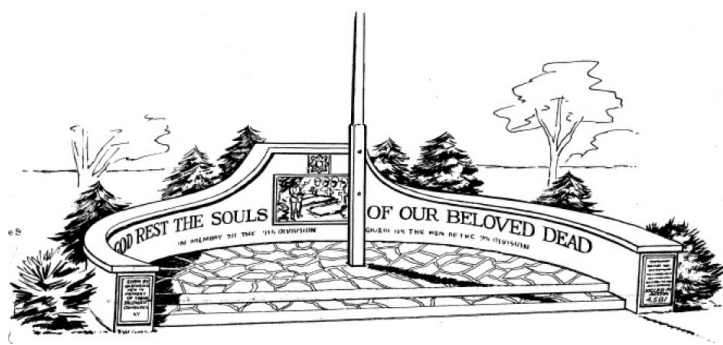

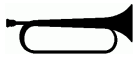

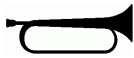

IN THE LAST 75 YEARS...

This is the fourth and final article by Terry Barnhart that will trace the history of the Ninth Infantry Division Association as reported in The Octofoil newsletters. Mary Blann Cooper also contributed information and the photo. The newsletters from 1947-2006 can be viewed online at: holycross.edu/archives-and-special-collections/college-holy-cross-special-collections-digital-collection. Unfortunately, as of this time, newsletters since 2006 to present have not been scanned for online viewing.

Passing the Torch

After almost sixty years as a military veterans group, the ranks of the organization were thinning due to age and illness. The 58th Annual Reunion was held in Houston, Texas in 2001. Mary Blann Cooper and her sister, Bette Prochaska, helped their father, 47th I.D. veteran Jack Blann, with the reunion. It was at this successful reunion that they met many other veterans' adult children such as Jim Merrill and John Sabato that the seed of an idea was born. Why couldn't the sons and daughters form their own group to socialize and assist their aging parents at the annual reunions?

The ad hoc group continued to socialize informally, often in Mary Cooper's room, at the next several reunions in Pigeon Forge, TN; Lancaster, PA; Monticello, NY; and Washington D.C. Over the years the group grew and bonded into lifelong friendships similar to their fathers' associates and friendships. Mary Cooper and John Sabato began helping the Women's Auxiliary with the registration at the 2003 Lancaster, PA reunion, which continued for the subsequent reunions. Mary published a brief notice about the formation of the Sons and Daughters group in the January 2004 newsletter, with The Octofoil editor noting support for the group.

The first formal meeting of this group met at the next reunion in Washington, D.C. in 2005. Approximately 165 members joined and the Women's Auxiliary was very supportive and donated \$75 to help the new group with postage expenses. The Board of Governors approved the volunteer group as the second auxiliary organization to the Association. The second meeting was held during the Branson, MO Reunion in 2006. This seems to be the turning point for the group with the establishment of provisional officers (Mary Cooper, John Sabato and William Sauers) and the creation of an Association website with Torry Crass. (In 2010, the website crashed and it was deemed too expensive to try to recover. This would be rectified in future years.)

In 2006, the previous Association secretary and The Octofoil editor, Joe Killen, resigned. Bill Robey was appointed as secretary/treasurer and new Sons and Daughters member, William Sauers, was appointed as provisional Octofoil editor. Sauers and John Sabato worked to redesign the newspaper formatted newsletter into an 8 ½ by 11 booklet to help save costs. It was not overwhelmingly accepted by the Association members at first, but the format survives to this day.

The new Sons and Daughters Auxiliary grew to 143 members in 2007 and Clare Irwin became the secretary. At the 2008 Orlando reunion, discussion was initiated about starting an Octofoil Library Project to preserve and document various published and non-published materials about the 9th Infantry Division which would be useful in learning more about the Division. Many Association members responded by donating money and materials including letters, diaries, memoirs, books, photos, artifacts and newsletters. The Sons and Daughters contracted with RMMI to digitize several thousands of pages to create an impressive library of materials. These documents were later donated to the College of the Holy Cross archives in Worcester, MA in 2013. This was the alma mater of the beloved, late

Father Edward T. Connors.

The Sons and Daughters Auxiliary also began discussion of creating some long overdue memorial plaques that recognize and honor the 9th Division. Terry Barnhart coordinated the design of two bronze plaques, one at the Ludendorff Bridge in Remagen, Germany (2010) and a second at the Huertgen Forest Museum near Schmidt, Germany (2011). Later discussions also began about renovating the Worchester Memorial at the Immaculate Conception Parish.

In 2011, the successful 66th Reunion was held in New Orleans with the Saturday night event held at the World War II Museum. However, months later the Association found itself in financial distress. The secretary/treasurer and reunion chairman had refused to pay reunion bills and embezzled almost \$27,000 going back to 2009. Joe Maiale remained as president and the Association bylaws were changed to allow full membership to Sons and Daughters members and Vietnam veterans. William Sauers was elected treasurer and Clare Irwin was elected Association secretary. The Sons and Daughters then used their separate checking account and over \$2,300 in funds to help the Association through these difficult times. Both Maiale and Sauers worked tirelessly to resolve the financial and legal issues. Later Prince George County (Maryland) District Attorney pressed charges, the defendant pleaded guilty and compensation was eventually recovered from the accused individual. The Association also collected on an employee position bond and all outstanding invoices from the 2011 reunion were paid by early 2013.

Successful reunions at Pittsburgh and Charleston did much to bolster the spirits and to rejuvenate comradeship of the Association. Members of the Sons and Daughters Auxiliary were recognized by the elderly Association members as productive and valued members of the Association.

Under the presidency of WWII veteran, Paul Schumacher, several younger members of the expanded Association were elected to the Board of Governors in 2014. William Sauers resigned as treasurer and The Octofoil editor and Jane Mitchell and Theda Ray were appointed as co-editors. Mary Cooper was elected as treasurer and as a result of the financial crisis, the Association hired a CPA firm to audit the financial books of the Association.

In 2014, the Worchester Memorial was renovated using some of the recovered funds from the New Orleans reunion in time for the annual services lead by the parish pastor Father Riley. The 2015 reunion was held in Warwick, RI, and the entire reunion was bussed to Worchester to see the memorial. The parish conducted a special service for the Association and served a dinner with a play honoring Father Connors and the 9th Division.

Also, at the Rhode Island reunion, the torch was finally passed to the next generation with Terry Barnhart elected as the first non-military president. Because of the changing status of the membership, a resolution was passed to explore the possibility of changing from a veteran non-profit to another type of non-profit.

In 2016, at the Ft. Myers, FL reunion, a new motto was approved: "If we don't remember, who will?" The Association also welcomed our first Vietnam veteran, Col. Charles Bonney (retired). Several other Vietnam veterans have recently joined the Association. A veteran's travel fund was established to encourage 9th Division veterans to attend the reunions. Later, the Association transitioned from a 501(c)19 veterans group to a 501(c)3 non-profit social group, but retained the same purpose to honor and remember the 9th Infantry Division. Janet

The following article was written by 9th Infantry Division in WWII researcher Yuri Beckers. Yuri has been preserving the history and memories of the 9th Infantry Division for many years and has the research web-site <https://9thinfantrydivision.net/> which provides a lot of great information. He is also writing a book about the 9th Infantry Division's actions in the Hurtgen Forest. His research helped to identify a group of missing soldiers in the Hurtgen Forest, which is detailed in the following article.

9th Infantry Division Men Going Home After 76 Years

On October 14th 1944, a group of 33 men of Company C, 60th Infantry Regiment, went missing in action after attacking a series of pillboxes in the Raffelsbrand area in the Hurtgen Forest.

The battles these men participated in were brutal. Starting out from the forest area near the Deadman's Moor, the 60th Infantry Regiment attacked on the 6th of October 1944 in a western direction. Their objective was the crossroads at the southern part of the town of Germeter, known as Richelskaul. After a couple of days of hard fighting, they cut the main road here and took control of the objective.

From here, they moved south alongside the main B-399 road, dealing with more bunkers as they advanced. After they took the Raffelsbrand crossroad as well, the men of Company C dug in just west of the road, facing a series of enemy bunkers, entrenchments, barbed wire, mines and heavy machine gun nests on the other side of the road. Snipers were in the area as well. During this period, American artillery and air support was throwing rounds of explosives on the area too. The noises were deafening.

The men attacked under tough circumstances. On October 12, 1944, the 1st Battalion captured two pillboxes (above ground bunkers), and moved their lines forward. However, control of the bunkers changed hands a couple of times. Staff Sergeant Blanton and the men of C Company attempted to take more enemy pillboxes, but were met with very heavy resistance. On the 13th of October, the men of C Company attacked another bunker and tried to keep their grounds. The German forces then called in artillery and mortar fire onto their own positions, on top and around the bunkers where the Americans were. A deadly mix of sharp, hot metal and wood splinters from the trees rained down on the men. Explosions, shock waves as a result from these and deadly fire from surrounding snipers and machine guns, all found their way to the men.

Because of the intensity of the ongoing battle, other men could not go out to recover any of the wounded. The next morning, 33 men of C Company were missing. After the war, all of the missing except for four men, were accounted for. The four men still missing were Staff Sergeant Raymond Blanton, Private First Class Clarence Brotherton, Private First Class Leslie Shankles and Private Walter Reuter Jr.

Because of the terrible state the 60th Infantry Regiment was in at the end of October, another Division took over operations in this area. The war moved on, and after the war, the area was searched by foresters and bodies were recovered. Some of these remains were unidentifiable and buried as "Unknown soldiers" at the American Cemeteries in Belgium.

In 2009, a dog tag was found in the area where these men went missing. The dog tag belonged to Private Walter Reuter Jr. No other items or remains were discovered. On the spot where the dog tag was found, a make shift memorial was put

up in the form of a pile of rocks and pieces of concrete of the bunker that was blown up after the war. Several war relics were added, and in September 2011, I added 2 pictures. One of Private Reuter, and one of Staff Sergeant Blanton. Since then, the memorial really started to live, and many people visited the spot since.

Nancy Fraker, the niece of Raymond Carlyle Blanton started her research in 2008 to gather as much information about her uncle as possible. Several years ago she also contacted the DPAA, the Official U.S. Government organization for the Defense POW/MIA Accounting Agency and an investigation that was started a few years earlier, was picked up again.

During this time, I also got in touch with Mrs. Fraker, and also started to investigate the actions in the area where these men went missing. After months of studying reports, I too created a detailed report that showed the movements of these men, the last known locations, the bunker positions, I matched up the German eye witness reports, studied map overlays, and created timelines. We also studied the X-numbers. These are the numbers given to unknown soldiers. Reports created upon time of finding the remains contain a lot of information that we could use to determine if any of these might have been one of these missing four men.

After all the research, I contacted DPAA as well, and we matched our findings. It was clear that the combined research of Mrs. Fraker, the DPAA Historian and myself, were conclusive enough to exhume several of the Unknown soldiers' graves from the American Cemeteries and perform DNA tests on. By then, I tracked down families of these four missing men as well, and urged them to contact DPAA and provide DNA samples as well, which they all did.

In 2018, we received the great news that the first man, PFC Leslie Shankles, was identified as a result of our combined efforts. This was wonderful news, and after 74 years, his family could welcome Leslie home again, where he now rests.

At the end of April 2020, we received more great news. Private First Class Clarence Brotherton and Staff Sergeant Raymond Blanton had been identified too. You can imagine how special this is. These men were missing for 76 years, and now have been identified again.

We now keep our hopes up that we will hear positive news about Walter Reuter Jr. soon.

These men fought side by side as brothers, and died side by side. They have forever been connected. We can live in freedom today because of their sacrifice, and we must never forget them.

As custom, a rosette will be placed behind their names on the Wall of Missing at the American Cemeteries.

Private First Class Brotherton and Staff Sergeant Blanton are going home later this year, where they will finally get their well-deserved, last resting place, close to their families.

Let us all remember these men.



Minutes of the 229th Board of Governors Meeting

Treasurer's Report

The Financial Report for Reunion 2019 was presented. Comments on the report were the following: The Octofoil is self-sufficient, and is doing fine with the money they have been given. Mary Cooper needs a list of Veterans in attendance at the Reunion, in order to reimburse them for their registration. The amount of money for the Friends of Father Connor fund needs to be watched. There will be ongoing repairs that will be needed, so we may need to look into adding money to this fund, maybe from the raffle money. 2013 and 2014 Reunion money was transferred to Account #7 – Vets Travel Fund. Janet Schnall made the following motion. MOTION: To approve the Treasurer's Report as written. Peter Stern seconded and the motion passed.

Membership Report

Clare Irwin has been updating the data base annually from April 2016 till now. She found 1200 -1300 names on the list prior to 2016. In 2016 there were 167 members and last year there were 90. How do we maintain our membership to get us into the future? We need to investigate this further. We might ask at the general meeting for people to call or contact past members. The database is also used for historical purposes, and to record dues. Money will be needed to grow the organization. Mary Cooper stated that things may need to change since we are now a 501(c)3 organization and will make up a budget for next year.

OLD BUSINESS

501(c)3

Accountant will finalize the paper work and Mary Cooper will check with the lawyer to see if there are regulations that we need to follow. We will need to put 501(c)3 on The Octofoil permanently.

We have 3 WWII veterans, 1 Vietnam veteran, and 6 new Vietnam veterans in attendance at this reunion. Table discussion.

Facebook

Clare Irwin, Mary Lovell, and Terry Barnhart looked at this to see about working with Torry Crass, but it didn't work out. Another web master, Yuri Becker, from Germany, has written a book. He lives in a town liberated by the 9th and has offered to set up a separate website for us. We decided we need to keep it based in the U.S. We want a domestic website. Terry Barnhart and Clare Irwin will find domain names for future discussion. Table discussion for now.

NEW BUSINESS

Growth of Association

Discussion on using Facebook and Website. After the Website is up and running, we can advertise our reunions. Hopefully we will gain a few new members this way. Posters were made for us to put up in Veterans posts. Charles Bonney will look at his magazines to see how they post their ads. He will also get a list of Publications.

Huertgen Forest

Second and third generations are becoming interested in what happened during WWII. We received about \$1,470.00 from a former member. Are we interested in placing plaques in battle sites of the 9th Infantry in WWII? Committee to investigate possible sites. Paul Schumacher would work on a committee of three or four, formed by Terry Barnhart.

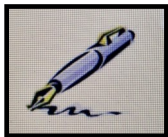

Pen to Paper - Letters to Loved Ones



The following letter from his father was submitted by Venard Paul Dean Jr. He is a new member of our Association. We welcome him to our Ninth Infantry Division Association family!

From Venard Dean
From somewhere in Germany
December 25, 1944

Dear Folks:

I received your letter of the seventh, last night, Christmas Eve. It was a real gift to hear from you at that time. I hope you all had a nice Christmas. I'm doing fine, don't worry about me. I heard Mass and received Communion, both yesterday morning and last night at midnight. We had Mass in a tent with the artillery booming all around us. It seems as though, every time, we start a Mass, our boys open up with a barrage, but as long as it's going into the German lines, it's music to my ears. Our new Chaplain, Father Curtis, is very nice, much younger than the other one, and very jolly. He's on the ball, and last night, he had us all singing Christmas carols at the Mass.

I'm glad to hear that you fixed Tony and Mary up with something for me. Thanks a lot. I meant to send some money to Ed and Retta to get something for the kids, but I forgot all about it, when the time came. I'll have to fix them up, later. I sent Mary a little bottle of perfume, from Paris, that one of my buddies got while in there on pass. I thought perhaps I'd be able to get a bottle for Retta, also, but it doesn't look like I'll get a chance, now. They've all been good to me and I don't like to slight anyone, altho, it's a difficult thing, to remember all and get into the spirit of Christmas with a war going on and conditions with me, the way they are.

Enclosed are some more pictures, you should be receiving quite a few for me, by now. I heard Eugene received his camera and is enjoying it very much. Does Paul have one? It's a nice thing to have, especially a small one that is easy to carry around. I'll bet you Eugene is getting his fill of canned rations out there in New Guinea. I put up with the same thing in Africa and Sicily. In fact there were days when even water was hard to get. We're getting fed good over here, I know I'm not losing any weight. Well, I'll sign off again, for now. Take real good care of yourselves. Give my best to all and God bless you, always.
